

## SCHOOL BUS SERVICE

### Terms and Conditions

1. The bus fare is determined based on the distance between the residence for pickup/drop-off and the School, obtainable from <https://maps.google.com.sg> by direct input of the addresses concerned (no further deliberation of details required), with reference to the table of rates shown below.
2. All charges shown above are in Singapore dollars and subject to prevailing GST rates.
3. Distances exceeding 14km may be subjected to an additional surcharge to make it financially viable to offer the school bus service.

We will charge S\$ 26.61 (S\$ 29.00 with GST) per km as an additional surcharge for Academic Year 2024-2025.

**Payment must be made by the due date stated on the invoice. Kindly note that the final route planning and seat will be confirmed only upon payment.**

For early termination of the bus service, a written notice must be submitted to the school bus office at least 3 weeks prior to the termination date. Policy on refund, if applicable, will be in accordance with the refund policy for course fees.

Bus routes are planned ahead with the objective of ensuring a smooth journey in the shortest time. Drivers are therefore not authorized to make any changes without the approval of the school.

**The provision of school bus services are subject to prevailing conditions and bus availability. ISS requires at least 4 weeks advance notice for new applications or changes to pick-up (or drop-off) locations during the academic year. Late submission of applications or notice of change may result in students not being able to ride the bus on the desired date.**

The bus route, pick-up time and arrival times are subject to unexpected road and traffic conditions beyond the control of the drivers. However, all effort will be made to minimize any inconveniences caused and keep the delays to no more than 15 minutes for morning pick-ups, and not afternoon drop-offs.

Where the students' residences are not on main roads or the locations are inaccessible for any reasons, they must walk to the pick-up location as designated by the school bus office. Students residing in condominiums or apartments should wait for their buses either at the security guardhouse, clubhouse or main gate as designated by the estate's Management Office. Students may also be required to cross the road to board the school bus if the bus is travelling in the opposite direction.

Unauthorised personnel, parents, family members, guardians and domestic helpers are **NOT** allowed to accompany the children on the bus.

All students attending **Grade 3 and below** should always be accompanied by an adult when boarding and alighting from the school bus.

For morning pick-up, students are reminded to be at the pick-up location at least 5 minutes before the stipulated pick-up time. There will only be a 2-minute waiting time before the bus moves off to the next location. **If the student missed the bus, he/ she will have to find alternative transport to school, at their own cost.**

On return trips, there should be a designated adult to wait for students in **Grade 3 and below** at the drop-off location at least 5 minutes before arrival time. In the event that there is no adult waiting at the drop-off location, the bus will return the student back to the school campus for security reasons. Parents will be informed to pick their child from school at their own cost.

If the parents decide to keep the student at home for any reasons, the parent or designated guardian should contact and inform the School Bus Office or driver in advance.

If the designated adult missed the pick-up at the drop-off location, he or she should contact the School Bus Office to make alternative arrangements or arrange to pick up the child at the next drop-off location.

Should there be any change of pick-up (or drop-off) location during the academic year, the parent or guardian should formally inform the School Bus Office at least one month in advance to incorporate the new location. Ability to incorporate the new location among the existing bus routes is subject to the possibility of fitting it into existing bus routes and seat availability. Parents may want to consult the School Bus Office prior to their move to confirm that the school bus services will still be available.

For any bus related matters, parents can contact Mr. William Cheong, Senior Transport Executive at the School Bus Office on school days from 7:30am to 5pm; Mobile no. **9663 6100**; email: [schoolbus@iss.edu.sg](mailto:schoolbus@iss.edu.sg) Alternatively they can also contact the respective office secretaries to convey messages to the School Bus Office. ISS contracts bus operators to provide bus services for its students. This service is offered at the request of the parents or guardians. ISS will make the necessary arrangements with the bus contractors on behalf of parents and work closely with them to manage the daily bus operations and services.

All applicants must agree and sign a **Release Waiver and Indemnity Agreement** prior to the confirmation of the bus service.

Students travelling on a school bus are expected to strictly adhere to the following rules and regulations:

- Students should be at the designated pick-up location at least 5 minutes before the stipulated bus arrival time. The bus driver will only give an allowance of 2 minutes if the student is not at the pick-up location upon the bus arrival. The bus will leave for the next location after the 2-minute waiting time.
- Seat belts should be worn at all times during the bus journey.
- Littering, smoking and chewing gum are strictly prohibited.
- Students shouting, quarrelling or using coarse or vulgar language will receive a warning from the bus attendant.

# Educating to Make a Difference



- Eating and drinking, other than plain water, are not allowed on the bus.
- Pets are not allowed on the bus (except with approval from the Principal's Office).
- Students should not carry sharp objects such as pocket knives on the bus. Other potentially harmful items such as scissors, pen knives, pencils, pen, etc. should be kept inside their school bags during the journey.
- Students who opt for a one-way service (home-to-school or school-to-home) will only be allowed to board for their opted trip.
- Students can only board the buses assigned by the school.
- Students should use the specific seat assigned by the School Bus Office. The seating arrangements will follow the principle of allowing the younger children to be seated nearer to the bus attendant or at the front rows. Students are not allowed to switch their seats without the approval of the bus attendant.
- The bus attendants are tasked to ensure safety and discipline on the bus at all times and students should follow their instructions. Students should be courteous and respectful towards the drivers, attendants and other passengers.
- Students should inform the bus attendant in advance if they know that they will not be taking the bus on any particular school day.
